### ***9.00 First Year Student Caucus Representative***

**9.01** The First Year Student Caucus representative shall:

- (1) Be elected via the Election guidelines laid out in the SSSC Elections Policy;
- (2) Represent the First Year Student Caucus on the SSSC;
- (3) Represent Social Science students on the First Year Student Caucus;
- (4) Vice chair the First Year Outreach Committee;
- (5) Be responsible for the development of ideas for promotion targeted at first years for council at election times and/or when Council requests it;
- (6) Sit on at least one committee or sub-committee of Council during her term in office; and
- (7) Serve her term in office until the beginning of the next academic school year.

### ***3.00 Communications Committee***

**3.01** The Communications Committee shall:

(1) Be composed of:

- a. (i) the Vice-President Communications, as Chairperson;
- b. (ii) the President (at the discretion of the Chairperson);
- c. (iii) the Commissioner-at-Large Communications (as recording secretary);
- d. (iv) at least one (1) USC Councillor, (1) Department Representative and (1) Residence Representative as nominated by council;
- e. (v) any student(s) at large at the discretion of the Chairperson;
- f. (vi) the Socializer Editor-in-Chief;
- g. (vii) the Internet Commissioner;
- h. (viii) the Graphics Design Commissioner; and
- i. (ix) the Advertising Commissioner.***

(2) Work together to ensure that the council remains a visible and accessible body to the students of the Social Science Faculty;

(3) Communicate the objectives and operations of the council to the student body; and

(4) Work in conjunction with the Advertising Commissioner in soliciting advertising for the *Socializer*.

## **5.00 Finance Committee**

**5.01** The Finance Committee shall:

- (1) Be composed of
  - (i) the Vice-President Finance, as Chairperson;
  - (ii) the President (at the discretion of the Chairperson);
  - (iii) the Commissioner-at-Large Finance (as recording secretary);
  - (iv) *the Advertising Commissioner;***
  - (v) at least one (1) USC Councillor, (1) Department Representative and (1) Residence Representative as nominated by council; and
  - (vi) four (4) student(s) at large at the discretion of the Chairperson.
- (2) Review any requests and/or applications for funding and make recommendations to Council.

- (2) Work together to ensure that the Council organizes strong academic events and participates in university-wide academic activities; and
- (3) Actively create and implement new ideas and initiatives to promote academic issues within the Faculty of Social Science.
